Carefully read this brochure and the tour conditions as enrollment in and payment for any program offered herein constitutes acceptance and agreement to be bound by the terms thereof.

Hotels: 3 or 4 star hotels throughout. All hotels are with private bath or shower. Per cost based on sharing twin-bedded rooms.

Children: For children 8 years of age or older, full land cost applies. Unaccompanied minors under 18 years of age cannot be accepted.

Meals on Tour: As specified on itinerary. Meals are based on hotels or restaurants buffet or set menu. In general, beverages are not included.

Transfers: As indicated in tour itinerary, by deluxe motor coach and includes portage of one average-sized suitcase per person. Transfers are provided only on package arrival and departure dates

Public Holidays: On public holidays including, but not limited to religious holidays and national celebrations, some monuments and sites may be closed. On these occasions, touring itineraries may be amended to reflect changes.

Responsibility: Epic Journeys, LLC and its representatives abroad act only as independent contractors acting on behalf of neither the customer nor the suppliers and principals. All exchange orders, coupons, and tickets are issued subject to the terms and conditions under which such means of transportation, accommodations, and other services are offered or provided. The issuance and acceptance of such documents shall be deemed to be consent to the further conditions. Epic Journeys, LLC does not own or operate, the hotels, motor coaches, airlines, cruise lines, or any other service providers which compose their tours. Epic Journeys, LLC will not be held responsible for changes/cancellations of airlines, hotels or cruise ships. The travel agent and/or Tour Operator shall not be held liable for injury, damage, loss, accident, delay, irregularity in any vehicle, or through the default of any company, or person, engaged in conveying the passengers, or of any hotel proprietor, personnel, or servant or any other person otherwise in connection therewith. Tour insurance is available and strongly

recommended: All claims must be in writing. No refunds for services or sightseeing rendered and not used by tour members. Epic Journeys, LLC reserves the right to cancel, withdraw or change the tour in whole or in part at any time. The sole obligation of Epic Journeys, LLC is to refund payments received in connection herewith if not acceptable to tour members. All cancellations must be in writing.

Cancellations: Cancellation after final payment due date will result in loss of payment unless tour participant is able to find a replacement for the tour.

Deposits: Full payment of \$109 is due with registration. Registration deadline is September 30, 2017.

Non-smoking Policy: Smoking is not permitted on transfer and touring motor coaches.

Sightseeing: Will be operated in deluxe, air-conditioned, motor coach. It is your responsibility to arrive on time for all scheduled package components. Arriving late for any scheduled event may be considered a "no-show" in which case you will not be eligible for any refund for the unused service(s).
