**Air Transportation:** Jet economy class on connecting IATA and ATC carriers. Airfare based on roundtrip, non-refundable APEX reservations.

**Hotels:** 3 or 4 star hotels throughout. All hotels are with private bath or shower. Per cost based on sharing twin-bedded rooms. A limited number of single rooms are available at the supplement indicated.

**Children:** For children 8 years of age or older, full land cost applies. Unaccompanied minors under 18 years of age cannot be accepted.

**Meals on Tour:** As specified on itinerary. Meals are based on hotels or restaurants buffet or set menu. In general, beverages are not included.
